



Depicts where body was found by forensic investigators after first responders moved the victim




Forensic's Evidence Diagram

Victim's original position

Officer Jeff Pelo Night of the Crime, 3/31/1991:

"I observed threw the glass door a tennis-shoe sticking out from behind the counter [...] I turned and looked down at the victim he was lying on his chest. Legs were slightly bent left arm was under his body. Right arm was bent at elbow towards his chest. Head was facing the west wall."

Officer Paul Williams, Jamie Snow's Trial, 1/2/2001:

"The body had been a more laying on his side like on an arm, maybe the way some people would sleep on their side, and his knees were curled up towards his chest; and he would have been actually physically behind the simulated wood counter."

Jeff Pelo, 4/1/2020:

"He was behind the counter, head to the south, face was looking towards the west, feet to the north. Door is on the south side of the store, room is on the north."

Victim's Rescue position

Officer Jeff Pelo BPD Cold Case Interview, 3/2/1999:

"He was laying at an angle [...] About a 90 degree different angle than what he was layin originally [...] my assumption is that Paul Williams turned him over [...] he'd been moved before rescuse got there."

Jamie Snow's Trial,1/2/2001:

Officer Paul Williams: "Well, he had been moved [...] if you get back behind that counter, there is no real room to work. [...] So he had been moved where there is a little bit more space."

Prosecution: "Tell me if this is an accurate statement of not. If he is laying on his left side there inside that corner, if you set him up so that his back was against the L shape of the counter and then brought him out to the end of the counter and laid him out and spread his legs out, would that be an indication of the movement the was involved here, just by sitting him up and then laying him down?" Officer Paul Williams: "Well generally speaking, yes, that would be generally how I think I had done that."

Jeff Pelo, 4/1/2020:


"180 degrees is not accurate. That was either Katz or Barkes saying that during the March 2nd 1999 interview. I stress he was moved by Williams from behind the counter and Williams cut open his shirt. This was a big DO NOT DO by BPD SOP."


