Reporting PATROL SERGEANT DANIEL DONATH - BPD, ID # 5430

On 08/10/06, Bloomington Police Department Records Manager Stephanie Bachman received 4 small sealed manilla envelopes from the Illinois State Police Westchester Laboratory. These envelopes contained DNA related evidence from old Bloomington Police Cases. The ISP lab was returning these items as they were no longer storing this evidence.

I took custody of these 4 envelopes on 08/11/06. I opened two of the envelopes to determine their contents. One contained a vial of evident DNA evidence. The other envelope contained 3 smaller envelopes. I opened one to find 3 small Q-tips, evident swabbings. I spoke with Lt. Stanesa. He advised to write one general report and submit these 4 envelopes in to standard evidence. This had been done twice before with evidence returned from other ISP labs. The cases from this evidence are all closed, but he wanted to make sure we maintained the evidence for any future use. Consequently, I resealed the opened envelopes. I packaged all 4 envelopes together. I made an evidence label for them and affixed it to the packaging. I sealed the package with red evidence tape. I signed the tape with my name, ID number, and the date. I transferred this package to Bloomington Police Department evidence locker #8.

The cases with evidence returned are: 96000394, 96007443, 96007306, and an unknown Bloomington case number (ISP case # P85-000177).

On 1/25/16, I pulled property #110201936 (Old Cases, DNA Stain Cards), to look for any property linked to 91-2150 (James Snow/William Little). Unable to locate any property for this case, I noticed that per supplemental report #6, dated 8/06/09, Sgt. Donath removed the blood stain card (which had no individual property id label) to transfer to ISP.

When the stain card was returned to the BPD on 2/12/10, a separate property label #110311056 was created in EJS incident report 200815989, where it remains.

Therefore, property no longer exists in this report from incident 91-2150.
