N		On 4-17-91, at approximately 0820 hrs., contact was made with _____ regarding _____ any information on Bill Little. _____ stated he met Little three years ago while working at the pool in LeRoy but became close in the Summer '90. The last time he saw Little was approx. 2 weeks before he died at residence but he acted normal. In regards to Little working at Clark Oil, Little thought it was boring and stated that if someone tried to rob him, he would have to see a gun before giving any money. Little also would say that if he was ever killed, they should throw a party and not let it effect them. _____ listed one enemy of Little's as being a Pat from Gibson City who was dating the same girl as Little. _____ only knew that there was a confrontation in which Little and Pat had a verbal confrontation which resulted in Danny Hartley hitting Pat but they left when Pat wouldn't fight. Another enemy of Little's was a Chad Baker who had had a couple of physical confrontations with Little (refer to lead L-232A). Chip Givens is another person listed as an enemy of Littles but he doesn't feel he fits the composite. _____ felt it was strange that Givens got a haircut the day or two after the murder. In regards to gambling, _____ hung around with Little at the LeRoy Pool Hall and stated that never bet more than \$20.00 in pool or cards and _____ doesn't remember Little ever owing money to anyone. _____ did state that Little was a user of mostly _____
