## Scuffle follows man's sentencing

Isaac Gaston, 19, Havana, was subdued by a sheriff's deputy, an assistant probation officer and court personnel Tuesday morning after being sentenced to prison on a forgery conviction.

. Court officials said Gaston threatened he'd kill himself after Circuit Judge Wayne C. Townley Jr. sentenced him to 1 to 3 years in the state pentitentiary.

Gaston attempted to break away from Deputy Sheriff Brett Beyer as he was being led out of the courtroom, officials said.

Beyer forced the prisoner to the floor and handcuffed him in the hallway outside the courtroom with the aid of David Trainor, assistant McLean County adult probation officer, and Clarence Adkins, bailiff in Townley's court.

Gaston had pleaded guilty to two

counts of forgery Feb. 13 after reaching a plea-bargaining agreement with the McLean County state's attorney's office.

That agreement called for a 1-to-3-year prison sentence, but afforded Gaston the opportunity to seek probation instead of a prison sentence.

Gaston, who had failed to appear for sentencing April 3 and May 17, had been held by sheriff's police at county jail since being picked up on a bench warrant May 23.

He had pleaded guilty to forgery of two checks, totaling \$45 and \$50, at the National Bank of Bloomington on July 24 and 26.

Gaston was arrested in the 1800 block of West Olive Street in connection with an April 29 incident involving a 13-yearold girl.



### Unlawful restraint nets three years

Isaac Gaston, 24, of the Hamilton Hotel was sentenced to three years in prison Monday for unlawful restraint of a Bloomington man in a May robbery. Gaston, who is in McLean County Jail pending other charges, was sentenced by Circuit Judge Wayne C. Townley Jr.

Gaston was convicted in a July 18 jury trial of restraining Stan Jolley May 16 in the 200 block of East Front Street. Gaston was acquitted of robbery and battery charges in the May incident.

# Man gets prison for jail incident

Isaac Gaston was sentenced Friday in McLean County Circuit Court to four years in prison for his part in a disturbance at McLean County Jail.

Gaston, 25, McLean County Jail, received four years for aggravated battery and three concurrent 364-day sentences on three battery convictions.

All convictions arose from an Aug. 13 disturbance in which Gaston threw a mixture of shaving cream and urine at four guards. One of the guards, David Curry, was hospitalized afterwards for chemical burns to his eyes.

Police said an attack by Gaston on Curry was unprovoked. Other inmates in the cellblock refused to return to their cells for a lockup until backup forces arrived.

Gaston, who threatened the guards with a homemade bludgeon made of bars of soap twisted in a sock, according to police, had to be physically restrained.

Gaston was awaiting a sentencing on an unlawful restraint conviction at the time.

Circuit Judge Wayne C. Townley Jr. handed down the sentence.

In other action Friday in circuit court, a 33-year-old Lexington woman pleaded guilty to embezzling \$18,500 from MCM Inc., 1107<sup>1/2</sup> Croxton Ave., while she was employed at the business.

The theft occurred between 1977 and 1979.

Carol Logsdon, who is free on bond, faces up to 30 months of probation under a plea agreement. She also may be ordered to pay back the missing funds. Circuit Judge Luther H. Dearborn

ordered a presentence report.

Ricky Rhule, 19, Louisville, Ky., pleaded guilty before Townley to charges that he burglarized Meadow's Co-op, Meadows, and Hauser's Service Center, Gridley, on June 21.

In return for the plea, charges that he burglarized Mr. Clyde's Tavern and Ringger Farm Center, both in Gridley, were dropped.

Rhule already has been sentenced in Livingston County to three years in prison for two other burglaries the same evening.

Rhule was remanded to jail while a presentence report is being prepared.

The agreement sets a maximum prison sentence of six years.

Also pleading guilty before Townley was Gregory Gene LaFever, 17, of 1800 W. Olive St. He admitted breaking into the home of Geraldine Brown, 1700 W. Olive St., on July 9.

He is free on bond awaiting a sentencing hearing.

### Sentence reimposed with 'magic words'

McLean County Circuit Court Judge Wayne C. Townley Jr. Thursday said the "magic words" and imposed the same sentence on a 26-year-old Bloomington man that he imposed Nov. 16.

Isaac Gaston, a resident of Pontiac Correctional Center, formerly of Bloomington, was sent to prison with a four-year sentence for aggravated battery and a 364-day sentence for battery. The sentences are to be served consecutively.

Townley handed down the same sentence in November. Both charges arose out of an Aug. 13, 1979, disturbance in McLean County Jail in which Gaston threw a mixture of shaving cream and urine at four guards.

Gaston appealed the sentencing and the Fourth District Appellate Court ruled the placing of consecutive sentences was improper because no justification was given.

Thursday Townley gave that justification which, he said, was adding the "magic words" that the consecutive terms are "in the public interest."

He said they are justified because Gaston was awaiting sentencing on another case when the incident in jail occurred.

### Fertilizer firm burglary nets 4½-year-term

A Bloomington man who blamed an April burglary of a Lexington fertilizer business on his co-defendant was sentenced yesterday to  $4\frac{1}{2}$  years in prison.

Joseph Alexander, 27, whose address was listed as 207 Mobil-Land Mobile Home Court, admitted being involved in the burglary of Myers Inc., but blamed the actual crime on Isaac Gaston, 29, whose address was listed as 1714 Springfield Road, Bloomington.

Gaston, however, told police a different story, claiming he was involved but that Alexander had committed the burglary.

Gaston has pleaded guilty to burglary and is awaiting sentencing.

Alexander, who had a prior record, was convicted of burglary by a McLean County jury last month.

Police said tools and a television set were taken in the April 10 burglary.

In another burglary case in McLean County Circuit Court yesterday, a Shirley man was sentenced to 3<sup>1</sup>/<sub>2</sub> years in prison for the April 22 burglary of a storage locker at an apartment building at 233 Robinhood Lane, Bloomington.

Gary Shelton, 19, pleaded guilty last month. Prosecutors will recommend he go to a minimum-security prison.

Police recovered a coffee machine and three bottles of liquor at an apartment at 612 N. McLean St. shared by Shelton and his co-defendant, David Stonestreet.

Stonestreet, who also pleaded guilty, was sentenced to four years' probation and 75 days in jail.

Police said the storage locker was pried open with a knife.
