On 11-12-91, Detective Crowe and Detective Harris went to the McLean County Jail and talked with [REDACTED] reference L-300-A. Miller stated that her husband, Jeff Miller, told her this past summer that he killed that kid at the Clark Station. He told [REDACTED] that he shot him with a gun and Jeff Durbin was with him in a get-away car. She said that they were married when Jeff told her but they weren't married when he did it, they were just going together and living together, on South Allin street.

Crowe asked [REDACTED] when the kid got killed and she said that he got killed in March or August of last year.

She went on to say that just recently Jeff robbed the Clark station on South Morris Ave. and he had a Blue mask on and had a BB Gun. He also robbed the Mobil Station on South Main street and also robbed a motel. She stated that she was in the mental treatment center in Decatur and Jeff called and told her he was in jail for the Armed robbery of Clark On Morris and the Mobil Station and the motel.

[REDACTED] stated that they have been married for seven months.

At the end of the interview Crowe was advised that [REDACTED]'s attorney Echols, was on the phone and wanted to talk. Crowe talked with Eckols who stated that he would rather we not talk to [REDACTED] unless he was present and if we wanted to talk with her in the future that we could contact him.
