On 03/23/99 R/O and Det. Sgt. Ron Maaks went to the Western Illinois Correctional Center in Mount Sterling Illinois and spoke with _____ in reference to this.

On 03/23/99 at 8:55 A.M. R/O took a tape recorded statement from _____ and the following is a synopsis of that interview. _____ stated when he was in Joliet Correction Center he had a cellmate named Jamie Snow. _____ stated Snow was bragging about a robbery that he had done. _____ stated he listened to Snow and Snow stated he had robbed a gas station and _____ stated he first thought of Billy Little. _____ stated he kept on talking to Snow about the robbery case and Snow stated he had been at the robbery with a gun. _____ stated at this time he did not know what business Snow was talking about where the robbery took place. As the conversation went on Snow stated how he went in as this was suppose to be a easy clean robbery but then the guy tried to come at him or something and he shot him. _____ stated he wanted to clarify where this incident took place and _____ stated he asked Snow if this was the Clark Station shooting and Snow said yes it was. _____ asked him if he was the only one and Snow stated no there were three of them. Snow stated someone was driving the car and the reason he did the robbery was because they needed money because they were smoking crack and they needed some more money. Snow stated they just happen to stop at that gas station and Little just happened to be working.

_____ stated this conversation took place with Snow in 1994. _____ stated they were celly's the first night in Joliet and the next day Snow and _____ were separated but they still met in the prison yard and talked about the Clark Station Case. _____ stated they were together about two weeks together in Joliet until they went to separate prisons. _____ stated during those two weeks together in the yard including the first night he and Snow talked at least 2 hours the first night in the annex. _____ stated Snow stated he shot the guy but he never told _____ what type of gun it was.

_____ stated Snow stated the guy came at him he also stated the guy was in a enclosure and the guy went to come around it and that is when Snow stated he shot him. _____ also stated Snow claimed he knew the guy he shot and he did not think he would come after him. _____ stated Snow called the person he shot by his initials B L . _____ stated Snow told him who was with him that night but at this time he could not remember those names. _____ stated Snow told him he shot the guy 3 times if he remembered correctly. _____ stated during those two weeks Snow said to him 2 or 3 times that he shot BL.

_____ stated Jamie was concerned about being seen at the Clark Station because Jamie said there were flyers all over town with a reward for a murder that he had done. _____ stated this all clicked for him which is why he asked if this was the Clark station case. Jamie stated there were flyers all over town and nobody had solved it yet ha ha ha. Jamie stated they have a \$25,000 reward for a murder that I did. _____ stated that is how Snow talked about it HA HA HA.
