I, the undersigned, Shannon Lee Schmidt, am 20 years of age, having been born
on 12-17-70 at Bloomington Illinois 61701
I now live at [REDACTED]

Present during this statement are Shonnon Schmidt, Detective Russell Thomas and Sgt. Mike Bernardini.

Thomas: Shannon, can you read and write the English langauge?
Schmidt: Yes, French too.

Thomas: Are you giving this statement on your own free will, without any threats or promises made to you by anyone?
Schmidt: Yes.

Thomas: Shannon, do you know a person by the name of Jamie Snow?
Schmidt: I met him once, I don't know him personally.

Thomas: How did you meet him?
Schmidt: I was at Ed's trailer one day, I don't know what the date was and Jamie came over to the trailer and he was sitting in the lazy boy chair when I came out into the living room and he said that he was Jamie. He asked me what my name was and after that I went back into the bedroom because Ed had told me about him and I didn't want to be around him.

Thomas: Who is Ed?
Schmidt: Ed Palumbo, he is my boyfriend.

Thomas: Tell me about a conversation that your boyfriend Ed Palumbo had with you about a conversation he had with Jamie Snow.
Schmidt: Ed said that he passed Jamie on Morris Ave and Jamie stopped to talk with him and Jamie asked him what was going on. Ed said nothing. Then Jamie asked Ed if he could get him some pot and Ed said no. Then Jamie said "Did you see me in the paper". Ed told me he said no, the Jamie said the gun went off and the kid died. Thats all that Ed said about the conversation.

Thomas: Do you remember what day that occurred on?
Schmidt: The day after it was in the paper.

Thomas: Would that be on April 1st?
Schmidt: It would have been on the second.

Thomas: Do you know how Ed and Jamie Snow met each other?
Schmidt: They were in prison together, where I don't know.

Thomas: Have you heard of a female by the name of Mary Cooper?
Schmidt: I didn't know her last name was Cooper. She lived by Washington School.

Thomas: How did you hear Mary Cooper's name?

Schmidt: Ed said that ^{was it} where Jamie Snow and Mike (LNU) were staying at.

Thomas: How often would Ed go to Mary's residence?

Schmidt: Maybe two nights a week, while I was at work.

Thomas: Were you ever over to Mary Cooper's house?

Schmidt: No.

Thomas: In the conversation you had with Ed Palumbo did he ever mention any other armed robberies or burglaries that Jamie Snow or Mike(LNU) may have committed?

Schmidt: One day there was a list in the paper of all the armed robberies and Ed pointed and said Jamies name at least once. It was the Clark one that occurred the day after Christmas. And another one I remember was the one where he mentioned Jamie and Mike's name and said they did the Freedom Oil.

Thomas: How did Ed know ?

Schmidt: I assume that they told him, but I don't know. He also mentioned something about Mary driving Mike over to Peoria to do a robbery. Ed said he told Rick Barkes over the phone about it.

Thomas: Is there anything else that you would like to add to this statement?

Schmidt: No
