N	On 05-28-91, DCI Agent Cox and I met with _____ at his residence in Normal to speak with him about his incarceration in the county jail. _____ stated he was in jail for a warrant on a battery charge that he claims he did not receive a notice for. He was asked what area of the jail he was in and he replied he was in G Block with about four or five others. When asked if he made any comments about the Clark Oil shooting to anyone, he first denied making any comments about the shooting to anyone. He then stated he was mad because he was arrested for no reason and another reason was that he had been drinking on the day he was arrested. _____ then admitted telling the two policemen that arrested him about him being a witness in the shooting and showed them my business card. _____ later stated that an inmate asked him if he was there and he told the person that he was. I asked him if he had made any comments and he said no. After several minutes, _____ still denied making any comments about getting free gas, or having any conversation with anyone while in the county jail. I advised _____ that if he remembered anything about his conversation in the county jail, to contact me as soon as possible. _____ Aproximately 30 minutes later, _____ came to the police department to speak with me.

N stated he remembers talking to one of the inmates in his cell block, but does not know the person's name. He stated the inmate had asked him if he was there when the shooting occurred and told him that he was. The inmate then said something about taking some free gas and said that he did take some gas. told me that after he made the statement to the other inmate, he told him that he was kidding. He then explained that he made the comment because he was still mad about being arrested and says it was the alcohol making him say that. He went on to say that everything else that he had said prior to this incident is the truth.
